
Federation member plans meet regularly to share information about health care financing and health care delivery in their home countries.





CT Scan: Abdomen (US\$)








CT Scans: Pelvis (US\$)




# Scans and Imaging Fees: MRI Scan (US\$)




# Hospital Charges: Average Cost Per Hospital Day (US\$)




# Hospital Charges: Average Cost Per Hospital Stay (US\$)






# Total Hospital and Physician Costs: C-Section (US\$)




**Cataract Surgery (US\$)**





# Total Hospital and Physician Costs: Bypass Surgery (US\$)








# **Physician Fees:**Normal Delivery (US\$)




## Physician Fees: C-Section (US\$)





# Source and Notes For Health Care Unit Price Comparisons

**UK** Based on NHS fee schedule

Australia Average hospital charges per day and stay: Based on Productivity

Commission October 2009 report

Drugs: Reflects standard co-payments for patient

**New Zealand** Physician fees for office visits : not covered by private health

insurance. government subsidy for General Practitioner visits (primary care capitation). Subsidies will vary depending on the eligibility of the patient. This calculated fee relates to the average cost not covered by

the subsidy.

Physician fees for normal delivery and c-sections: not covered by

private health insurance. fully funded by the government

Average hospital charges per day and per stay: Include all surgical procedures funded under private insurance. Cover a wide range of procedures and thus the average prices are heavily determined

according to the mix of procedures within.

# Source and Notes For Health Care Unit Price Comparisons (Cont'd)

### **France** Drugs: Reflect prices negotiated by hospitals including a 2.1% tax.

These prices that are generally much lower than drugs available in

primary care settings and pharmacies

Drugs - Lipitor : Reflects the prices for the generic substitute, Tahor

### Germany

Based on current Medical Fee Schedule (GOA) and represents the average costs per treatment

Total (Hospital and Physician) Cataract surgery fees: Excluded due to limited and non-comparable data definitions

Normal delivery physician fees: Reflects only the incremental private insurance fees paid to physicians above the annually negotiated medical fees which consists of fees per time period and per medical procedure. e.g., only incremental physician charges above the bundled DRG payment for specific procedures which consists of both total physician and hospital cost

Drugs: Reflect commercially available prices. No public fees available. Public co-payment schemes also vary greatly

# Source and Notes For Health Care Unit Price Comparisons (Cont'd)

#### **Netherlands**

Physician primary care fees (office visits): No equivalent in Dutch health system. General Practitioner remuneration system is based on a fixed fee per patient plus an additional 9 Euro consult fee.

Total (Hospital and Physician) fees: Estimated based on DBC (diagnose treatment combinations) which are negotiated mixed bundled payments model on per patient / diagnosis basis.

Components are not separated

Drugs: Reflect the standard public charges for patient. Excludes 6% VAT

### **Switzerland**

All fees except for physician inpatient fees are based on public fee schedule

Physician inpatient fees (Normal Delivery, C-Section, Appendectomy, Cataract Surgery, Hip Replacement): Based on private charges billed by hospitals for medical services. Physician specific component is not separated

# Source and Notes For Health Care Unit Price Comparisons (Cont'd)

**Spain** Fee schedule is as of Oct 2010 and reflects the competitive fees

charged by private providers.

**Argentina** Reflects a blend of fees for three health sub sectors; public health,

social security and private weighed by corresponding coverage of

the total population - 50%, 38% and 12% respectively.

Canada Hospital and Total (Hospital and Physician) fees: reflect 2009/10

relative hospital cost, based using fiscal 2009/10 acute care discharge data from the Canada Institute for Health Information (CIHI) Discharge Abstract Database and a relative dollar value of \$5,422 (fiscal 2008/09 - New Brunswick provincial average) for 1

RIW (resource intensity weights) or cost per weighted case (CPWC)

as provided by CIHI.

# Source and Notes For Health Care Unit Price Comparisons (Cont'd)

## Canada (Cont'd)

Average cost per hospital day: Includes only direct cost (no indirect or overhead cost)

Average cost per hospital admission : Based on acute hospitals only and includes newborns

Drugs: Reflects one month supply (30 days) covering base ingredient costs excluding mark-up and dispensing fees. Given that Nexium is not included in the New Brunswick Formulary, the comparable product, Losec, was used

Cost-based fees are not captured at a detailed level for various procedures including c-sections, angiograms
