- "5.2.3 Level C. The product shall be packed in a manner to ensure carrier acceptance and safe delivery at destination at the lowest transportation rate for such supplies. The shipping container shall be in accordance with the Uniform Freight Classification or National Motor Freight Classification, as applicable.
- "5.2.4 Shipping container for bulk packing of type I gum. Not more than twenty-five hundred two-tablet unit packs of type I gum shall be bulk packed in a snug-fitting fiberboard box, constructed, closed method II, in accordance with style RSC-L type CF or SF, class domestic, grade 200 of PPP-B-636."
